Debra Stifflemire, Executive Director of the Uvalde Convention & Visitors Bureau, reported that the Hotel Motel Taxes for the period of July through September 2014 were down to \$87,690.41 and that total assets for the Uvalde Convention and Visitors Bureau were \$331,157.34. Net Income from July through September 2014 was a negative \$10,437.81.

8B. Report by Kasie Morgan, Civic Center Manager, on the 4<sup>th</sup> quarter activities and income collections.

Kasie Morgan, Civic Center Manager, reported that the Civic Center had 44 non-income generating events, 8 City events, and 19 income events for a total of 71 events from July through September 2014 for a total income of \$20,210.00.

This Agency claims partial racial profiling report exemption because:

Our vehicles that conduct motor vehicle stops are equipped with video and audio equipment and we maintain videos for 90 days.

Certification to This Report 2.132 (Tier 1) – Partial Exemption

Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling

UVALDE POLICE DEPT. has adopted a detailed written policy on racial profiling. Our policy:

- (1) clearly defines acts constituting racial profiling;
- (2) strictly prohibits peace officers employed by the UVALDE POLICE DEPT. from engaging in racial profiling;
- (3) implements a process by which an individual may file a complaint with the UVALDE POLICE DEPT. if the individual believes that a peace officer employed by the UVALDE POLICE DEPT. has engaged in racial profiling with respect to the individual;
- (4) provides public education relating to the agency's complaint process;
- (5) requires appropriate corrective action to be taken against a peace officer employed by the UVALDE POLICE DEPT. who, after an investigation, is shown to have engaged in racial profiling in violation of the UVALDE POLICE DEPT.'s policy adopted under this article;
- (6) require collection of information relating to motor vehicle stops in which a citation is issued and to arrests made as a result of those stops, including information relating to:
  - (A) the race or ethnicity of the individual detained;
- (B) whether a search was conducted and, if so, whether the individual detained consented to the search; and
- (C) whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual; and

- (7) require the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - (A) The Commission on Law Enforcement; and
- (B) the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.
